District residents who are interested in receiving information about registered sex offenders residing within the Farmingdale School District, Nassau and Suffolk Counties, are directed to contact Parents For Megan's Law (PFML) at 631-689-2672 or [www.parentsformeganslaw.org](http://www.parentsformeganslaw.org) or by calling the Nassau County Police Department Special Victims Squad at 516-573-8059.

If you chose to participate in the PFML Email Alert Program, you will be actively notified by email when they are notified of the presence of a registered sex offender by Nassau or Suffolk County Police Departments or when they obtain official sex offender registration information from New York State [www.criminaljustice.state.ny.us](http://www.criminaljustice.state.ny.us). The Alert Program is an additional service free of charge which you would have to sign up for in order to be notified directly by email.

Parents For Megan's Law (PFML) will alert you via email when we are notified of the presence of a registered Level 1, 2 or 3 sex offender by Suffolk or Nassau County Police Departments, participating Long Island Municipal Police Departments or when we obtain official sex offender registration information from the New York State Sex Offender Registry. Information on registered sex offenders is always available from our website at no cost. The suggested donation helps to fund the services we provide, which include: advocacy for child and adult victims of sexual abuse and other violent crimes, sexual abuse and abduction prevention education workshops for children and adults, the Megan's Law Helpline and Sex Offender Registration Tips Programs, counseling services for children and adults and policy and legislative support services.
